FOSTER FAMILY AGREEMENT

The Foster Family agree to provide accurate and up-to-date information on all required paperwork and advise Jelly Exotics if this information changes during the time-period that the Agreement is valid.

Jelly Exotics will ensure the Foster Family address is checked and proof of identification is provided before any Foster Animals are permitted to enter the care of the Foster Family – this should be recorded in the "Foster Family Home-Check" form.

Jelly Exotics will work with the Foster Family to provide a safe, suitable enclosure for the Foster Animals. Any equipment provided by Jelly Exotics, given to the Foster Family for the purpose of housing Foster Animals, is to be included on the "Equipment Loan Form" and filed.

When a Foster Animal enters the care of the Foster Family, a "Foster Animal Exchange Form" is to be completed, agreed to and filed.

Foster Animals are to be housed at the Foster Family address ONLY.

The Foster Animals DO NOT belong to the Foster Family and CANNOT be rehomed, sold or temporarily housed elsewhere, with other individuals or organisations, without permission from Jelly Exotics.

If the Foster Family are going away and require additional care for the Foster Animals, Jelly Exotics should be notified, and any secondary care must be approved by Jelly Exotics.

The Foster Animals MUST NOT be used for any commercial or breeding purposes.

Jelly Exotics will give editing access to each Foster Animals Care Report document.

The Foster Family is responsible for updating the Foster Animals "Weekly Report", "Feeding Log" and "Weight Log", within the Foster Animals Care Report document. No other tabs should be edited by the Foster Family.

Jelly Exotics MUST be contacted immediately, if the Foster Family believe the Foster Animals require veterinary attention. Should a veterinary opinion be sought without Jelly Exotics permission, the Foster Family may be required to contribute the cost of the appointment, if deemed unnecessary by Jelly Exotics.

Any expenditure towards the Foster Animals food and upkeep may be reimbursed by Jelly Exotics, provided the expenditure is pre-approved by Jelly Exotics and a valid VAT receipt is provided by the Foster Family.

 $\label{thm:continuous} The Agreement may be terminated by either Jelly Exotics or the Foster Family, with no reason given, upon which the "Termination Procedure" will take place.$

Upon the end of the contract, with no renewal in place, the "Termination Procedure" will take place.

TERMINATION PROCEDURE

If either Jelly Exotics or the Foster Family wish to terminate the contract they must first inform the other party in writing, or via messenger/email.

Any Foster Animals being kept at the Foster Family address must be returned to Jelly Exotics at the earliest convenience, or immediately if due to a welfare concern.

Any equipment being used by the Foster Family as per the "Equipment Loan Form" must be returned to Jelly Exotics at the earliest convenience.

All data gained for the purpose of the Agreement is to be removed and/or destroyed by Jelly Exotics as per GDPR guidelines, once the Foster Animals and any equipment has been returned.
